## Professional Background

Following her graduation in South Africa, Mandy gained extensive experience within stroke rehabilitation, paediatrics, hand therapy and general medicine. Since relocating to the UK in 1994, Mandy has worked within the NHS in the areas of healthcare for the elderly, neurological outpatients, rheumatology, cardiology and neurological rehabilitation. This has included working with children and young people with brain injuries as both a senior occupational therapist and head of occupational therapy. This involved spearheading the assessment and rehabilitation of clients experience cognitive and behavioural challenges and those with severe physical disability, including vegetative states. This also involved training carers, working closely with families, coordinating discharges and accessing community and social services.

Mandy has lectured at South Bank University on therapeutic approaches in neurological occupational therapy and cognitive and perception. She has also delivered presentations on neurological occupational therapy at major conferences and training courses. Mandy currently operates as a consultant occupational therapist, working with Active Care Group for individuals with epilepsy, neurological conditions and learning disabilities. She has also supported their accreditation as part of the Headway approved provider scheme for brain injury care and rehabilitation. She provides neuro-treatment, supervision and consultation to organisations specialising in the rehabilitation and long-term placement of children and young adults with brain injury and challenging behaviour.
